## **Mystery Piano In Woods**

Authorities in Harwich, Massachusetts, are probing the mysterious appearance of a piano, in good working condition, in the middle of the woods.

Discovered by a woman who was walking a trail, the Baldwin Acrosonic piano, model number 987, is intact -- and, apparently, in tune.

Sgt. Adam Hutton of the Harwich Police Department said information has been broadcast to all the other police departments in the Cape Cod area in hopes of drumming up a clue, however minor it may be.

But so far, the investigation is flat.


Also of note: Near the mystery piano -- serial number 733746 -- was a bench, positioned as though someone was about to play.

The piano was at the end of a dirt road, near a walking path to a footbridge in the middle of conservation land near the Cape.

It took a handful of police to move the piano into a vehicle to transport it to storage, so it would appear that putting it into the woods took more than one person.

Asked whether Harwich police will be holding a holiday party in the storage bay -- tickling the ivories, pouring eggnog -- while they await word of the piano's origin and fate, Hutton laughed. No such plans.

## <u>The PTG Bylaws</u>: ~ A Grand Tour ~ part 35

#### ARTICLE XVI – PTG Home Office

#### Section A – Administration

The Executive Board shall hire an administrator for the PTG Home Office who shall have the title Executive Director.

#### Section B – Duties

1. Operate the Home Office of PTG, maintaining all necessary books and records in accordance with the accepted procedure.

2. Hire necessary personnel to operate the PTG administrative work within the PTG budget and under direction of the Executive Board.

3. Prepare a proposed annual budget for the following fiscal year. Submit the budget proposal to the Executive Board. After the Board has approved the budget, distribute to chapters as required by these Bylaws.

4. Annually and whenever directed, make available to the Executive Board all budgets, financial reports, records and recommendations.

5. Make all budgets, financial reports, records, and recommendations available to the PTG Council.

6. Coordinate PTG Annual Conventions.

7. Make all necessary records available for audit or other accounting examination or survey as directed by the Executive Board.

8. Distribute agenda books and proposed amendments to the Bylaws to chapters and the Executive Board seventy (70) days prior to the opening of the PTG Annual Convention.

9. Provide for the Council an annual report of activities of the PTG Home Office, together with all documentation necessary to clarify the report, and recommendations and suggestions appropriate for future PTG programs.

10. Provide administrative supervision and operation of the PTG Annual Convention as directed by the Executive Board.

11. In all publications to instruct the editorial board only to accept articles and classified advertising for publication that do not discriminate against any person because of race, color, creed, sex, or national origin.

## OBITUARY

Willis P. Snyder Jr., 87, died peacefully March 21, 2009, in the health care center at Phoebe Berks Village near Reading, Pennsylvania.

He was the loving husband of Kathryn (Ahrens) Snyder, whom he married in 1947. They enjoyed 61 years of marriage, 56 of which were spent living together by Furnace Creek in Robesonia, PA.

Born in Reading on March 7, 1922, Willis served in Patton's army during World War II and was awarded two Bronze Stars.

After the war, he worked as a welder at Parish Structural Products Division of Dana Corp. In 1956, he started a piano tuning and repair business that would become his passion for the next 50 years.

He was a charter member of the Reading-Lancaster chapter of the PTG, serving as secretary, vice president and president through the years.

He also served as a PTG instructor at the local, regional and national levels for more than 30 years and was a former national vice president of the PTG. His PTG awards include the Golden Hammer, Hall of Fame and Outstanding National Instructor.

He was a former member of the Robesonia Rod and Gun Club and was instrumental in building the club's fish hatchery and starting the annual fishing rodeo.

He was a member of the VFW Robesonia post as well as the Robesonia Fire Company.

He was also a member of St. Paul's UCC, Robesonia, and the Reading Bowling Association, having rolled a perfect game in 1995.

Surviving in addition to his wife are three sons: Sterling D. Snyder, Riverview Park; David B. Snyder, Robesonia; and Brian A. Snyder, Ruscombmanor Township; and three daughters: Marilyn R. Manuele, Chadds Ford; Eileen L. Mills, Douglassville; and Phyllis A. Snyder, Eagleville.

Other survivors include a brother, Charles Snyder, Stony Creek. There are also 10 grandchildren.

He was also predeceased by his stepmother, Evelyn Snyder; and two brothers, John and Thomas Snyder.
